Performa series promotional discount terms and conditions

- Promotion is valid on qualifying Cobra Electronics Performa 400/450 2-Way Handheld Business Radios (single units), Cobra Electronics Performa 400/450 2-Way Handheld Business Radios (6-packs), purchased and delivered from an authorized Cobra Electronics B2B reseller or distributor during the promotion period, April 13 to July 12th 2026.
- This promotion is structured as a tiered volume rebate. For single-unit SKUs (Performa 400 and Performa 450), qualifying thresholds and savings are as follows: purchase of 2 or more qualifying units receives a \$15.00 per-unit rebate; purchase of 5 or more qualifying units receives a \$25.00 per-unit rebate; purchase of 10 or more qualifying units receives a \$35.00 per-unit rebate.
